**2.a.1. Review of Guidelines for Public Hearing**

President Shea welcomed the audience and reviewed the guidelines to be followed during the Public Hearing and the order of speakers.

**2.a.2. Background Information on Public Hearing**

Assistant Superintendent of Business Services Lora Duzyk provided introductory remarks. On July 12, 2017, resolutions of the Oceanside Unified School District Governing Board to change to a by-trustee-area election system and approving a trustee area plan were transmitted to the County Board of Education, acting as the County Committee on School District Organization.

When considering a district's proposal to adopt an alternative method of electing governing board members and establishing trustee areas, Education Code section 5019(c) requires a county committee to call and conduct at least one public hearing in the district. On July 12, 2017, the County Committee approved a date, time, and location for this public hearing. The public hearing will be conducted in accordance with the attached guidelines approved by the County Committee.

### **2.a.3. Spokesperson(s) for Oceanside Unified School District**

Director of Facilities Matt Evans provided a presentation describing the steps taken and process followed by Oceanside Unified School District (OUSD) to change to a by-trustee-area election system and to establish trustee areas. OUSD Board President Gleisberg also addressed the Board.
