Business Services Consultant Kristin Armatis provided the following introductory remarks: On January 10, 2018, resolutions of the Cajon Valley Union School District Governing Board to change to a by-trustee-area election system and approving a trustee area plan were transmitted to the County Board of Education, acting as the County Committee on School District Organization.

When considering a district's proposal to adopt an alternative method of electing governing board members and to establish trustee areas, Education Code section 5019(c) requires a county committee to call and conduct at least one public hearing in the district. On January 10, 2018, the County Committee approved the date, time, and location for this public hearing.
