




This chart shows the total general purpose revenue Kavod Charter School expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for Kavod Charter School is \$5,387,324.00, of which \$4,428,961.00 is Local Control Funding Formula (LCFF), \$461,743.00 is other state funds, \$105,000.00 is local funds, and \$391,620.00 is federal funds. Of the \$4,428,961.00 in LCFF Funds, \$287,821.00 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).



Plan Summary [2022-2023]

General Information

Kavod Charter began the school year with 382 students shy of its enrollment goal. The LEA continues to seek opportunities for growth to promote a diverse environment where all explorers can celebrate their backgrounds through the Kavod model.

Reflections: Successes

A description of successes and/or progress based on a review of the California School Dashboard (Dashboard) and local data.

From the information published on the 2022 Dashboard we're happy to see student achievement in English and Language Arts and Math are high despite the impact of learning loss brought on by the pandemic. We also continued to keep a moderate level of suspensions and to date have not expelled any student. Kavod successfully also met all local indicators.

Reflections: Identified Need

A description of any areas that need significant improvement based on a review of Dashboard and local data, including any areas of low performance and significant performance gaps among student groups on Dashboard indicators, and any steps taken to address those areas.

Highlighted in the 2022 Dashboard was (like many LEAs across the State) a concern regarding regular attendance. Our chronic attendance rate was at a record 24% percent. It is the highest we've ever seen; the majority of which was a result of students missing school due to COVID illness. Additionally, Kavod identified student groups specifically impacted by chronic attendance and began to put systems in place to more closely monitor student group performance moving forward. Among those identified were English Learners, Hispanic, Two or More Races, Socioeconomically Disadvantaged and Students with Disabilities. Lastly, we identified a continued need to improve systems and school-to-parent communication with English Learners. Helpful feedback from the School Site Council (SSC) and English Language Advisory Committee (ELAC) highlighted ways the school can better support students.

Kavod Charter was recently identified for Additional Targeted Support & Improvement (ATSI) in 2023 needing to focus on students of 'Two or More Race' category. Through comprehensive needs assessments Kavod will identify areas of concern and develop a process to mitigate ways for student groups to not fall short of their potential. The school will take feedback from parents, teachers and student body and relevant committees to develop a strategy on how to move forward using Science-based strategies.

Staff has requested support with targeted professional development and additional support in the elementary due to the unplanned absences of the Director of Elementary. They have also expressed the need to continue to build community as departments are feeling neglected between other staff groups.

Parents via the ELAC Committee expressed a desire to be better informed of student achievement scores and the process of ELL identification to reclassification.

Highlights of the Healthy Kids Survey given to explorers 3+ grade are:

Elementary:

- 94% of explorers feel most of the teachers and other grown-ups at school treat students with respect.
- 93% of explorers feel the school teaches students to care about each other and treat each other with respect
- 95% of explorers are generally happy in school
- 97% of explorers feel teachers and other grown-ups make it clear that bullying is not allowed
- 96% of explorers feel safe at home

Middle:

- 93% of explorers understand the importance of the OLAM values
- 93% of explorers feel most of the teachers and other grown-ups at school treat students with respect
- 92% of explorers feel the school teaches students to care about each other and treat each other with respect
- 95% of explorers feel generally happy in school
- 88% of explorers feel safe at home

From staff feedback scheduling adjustments were made to better support supervision and collaboration times. Additionally, recommendations from staff prompted the appointment of a new Director of Elementary. School-wide we have taken steps to incorporate more of the Hebrew

language and cultural activities that address the focus of our charter. Feedback via the SSC prompted an updated School/Parent compact that more clearly defines how the school will support students. Feedback via ELAC prompted additional ways parents can keep abreast of student achievement by sending secondary score reports home as well as verified assessment data.

A substantial difference between planned action and implementation was the frequency in which Kavod Parent Committee meetings were scheduled. Additionally, the lack of community events and state-wide attrition rate has hindered outreach opportunities. As such we've contracted a marketing company to recruit families from multicultural backgrounds that are interested in the Hebrew language program at Kavod. Lastly, stringent rules around Independent Study coupled with the continued pandemic have exacerbated chronic attendance concerns.

A material difference between budgeted expenditures and estimated actual expenditures or planned percentages of improved services was born out of a decline in enrollment and chronic absenteeism.

The actions delineated have put the school on track to reach our goal in 2023-2024.

Staff was allocated extra prep time to support them in their issuance of Independent Study to help mitigate chronic absenteeism. Additionally, staff has expressed their desire to limit parents on campus but still provide opportunities for parent participation and support. The desire was born purely on a lingering safety concern.

A substantial difference is the on-going need to hire and retain credentialed staff, especially world language teachers. Due to staff attrition, we've had to adjust some assignments which has primarily impacted the elementary grades. Similarly, returning staff have caused the need to make some scheduling changes but this has all worked for the best as they're now able to support home room teachers through push in/pull out groups for Language Arts, Math and English Language Development Support.

Kavod Charter was flagged for Additional Targeted Support & Improvement (ATSI) in 2023. The Local Control Funding Formula (LCFF) requires local educational agencies (LEAs) to engage their local educational partners in an annual planning process to evaluate their progress within eight state priority areas encompassing all statutory metrics (COEs have 10 state priorities). LEAs document the results of this planning process in the LCAP using the template adopted by the State Board of Education.

The LCAP development process serves three distinct, but related functions:

- Comprehensive Strategic Planning: The process of developing and annually updating the LCAP supports comprehensive strategic planning (California *Education Code* [*EC*] Section 52064[e][1]). Strategic planning that is comprehensive connects budgetary decisions to teaching and learning performance data. LEAs should continually evaluate the hard choices they make about the use of limited resources to meet student and community needs to ensure opportunities and outcomes are improved for all students.
- Meaningful Engagement of Educational Partners: The LCAP development process should result in an LCAP that reflects decisions made through meaningful engagement (EC Section 52064[e][1]). Goals and Actions

Purpose

Well-developed goals will clearly communicate to educational partners what the LEA plans to accomplish, what the LEA plans to do in order to accomplish the goal, and how the LEA will know when it has accomplished the goal. A goal statement, associated metrics and expected outcomes, and the actions included in the goal should be in alignment.
