This document contains information regarding the Employer Address File. This document provides the basic guidelines required of an Employer Address File including detailed file layouts and file editing criteria.

The file guidelines section includes the basic requirements of an Employer Address File. This section provides useful information regarding the basic file structure of an Employer Address File.

The file layout section includes detailed field information required on the Employer Address File by record type. This section provides useful information regarding each field value required on an Employer Address File by differing record type (Report Source, Unit Code, Employee name and address).

Each error is detailed by the following descriptors:

**Error number** – System generated number to identify the edit **Error message** – A short description of the edit **Resolution** – A long description of the edit and potential solutions

#### 1.2 Address File Business Rules

Error number: 001

Error Message: Not a valid Report Unit Code for Report Source

*Error Resolution:* Report Unit Code on the Address File line does not represent a Report Unit reported by the Source that the AF Media has been logged for.. The Report Unit can only contain numbers (i.e., 1,2,3,4,5,6,7,8,9,0). Change to a valid Report Unit.
