




This chart shows the total general purpose revenue Arroyo Vista Charter School expects to receive in the coming year from all sources.

The text description for the above chart is as follows: The total revenue projected for Arroyo Vista Charter School is \$10,020,300.00, of which \$8,656,570.00 is Local Control Funding Formula (LCFF), \$956,554.00 is other state funds, \$100,442.00 is local funds, and \$306,734.00 is federal funds. Of the \$8,656,570.00 in LCFF Funds, \$533,624.00 is generated based on the enrollment of high needs students (foster youth, English learner, and low-income students).

Of that amount, \$533,600.00 is tied to actions/services in the LCAP and \$9,481,400.00 is not included in the LCAP. The budgeted expenditures that are not included in the LCAP will be used for the following:

The majority of General Fund Budget Expenditures for the school year (not included in the LCAP) are the certificated staff members (teachers) that are not part of our Curriculum Experts rotation. Music, Art, Drama and PE are funded by the LCAP in partorship with our PTA


Increased or Improved Services for High Needs Students in the LCAP for the 2022 – 23 School Year

In 2022 – 23, Arroyo Vista Charter School is projecting it will receive \$533,624.00 based on the enrollment of foster youth, English learner, and low-income students. Arroyo Vista Charter School must describe how it intends to increase or improve services for high needs students in the LCAP. Arroyo Vista Charter School plans to spend \$483,000.00 towards meeting this requirement, as described in the LCAP. The additional improved services described in the plan include the following:

There is an increase of about \$70,000 over the amount in the previous year (2021-2022). This amount is almost entirely added to the Health and Wellness (counselor), Instructional Aides, and Curriculum Expert Areas where the impact and benefit will be focused on our Foster Youth, English Learners, and Low Income Students.

# Plan Summary 2022

### **General Information**

A description of the LEA, its schools, and its students in grades transitional kindergarten-12, as applicable to the LEA.

Arroyo Vista Charter School (AVCS) is a public charter school currently serving a TK-8 population. The school opened as a K-6 public school of the Chula Vista Elementary School District (CVESD) in July of 1999 with a population of 250 students. In 2000, parents, staff, and community members began a two-year process of developing the initial AVCS charter. The petition was approved by the CVESD and in July of 2002, AVCS opened as a conversion charter school. Arroyo Vista Charter School maintains a collaborative relationship with the Chula Vista Elementary School District. Located in the East Lake community of Chula Vista, CA, AVCS serves a culturally and economically diverse population. A 90/10 Spanish Dual Immersion (DI) Program was instituted in 2005 and currently serves students in grades K-6. Also, in 2005, all-day kindergarten was implemented for all kindergarten students. This year, 2022, all-day transitional kindergarten will be implemented. The population changes reflect a suburban community that has transitioned from original homeowners with young children to older families whose children are aging out of school. Enrollment changed significantly with the addition of the middle school program. Seventh grade opened in July of 2011, and eighth grade opened in July of 2012. There was also an interest from the community in early-childhood education; therefore, a transitional kindergarten (TK) program was added to the AVCS campus in the 2014-2015 school year. Present enrollment in the LEA, which consists of one school - Arroyo Vista Charter School, is 920 students, representing students in grades TK through 8<sup>th</sup> grade.

AVCS is a non-sectarian public school and does not discriminate against any person on the basis of gender identity, gender expression, sexual orientation, ethnicity, nationality, national origin, religion, disability, or association.

### **Reflections: Successes**

A description of successes and/or progress based on a review of the California School Dashboard (Dashboard) and local data.

Arroyo Vista Charter School is a high-achievement school. In English Language Arts, AVCS scored 71.5 points above the state standard. In Mathematics, AVCS scored 38.4 points above standard. The state dashboard qualifies progress level of English Learners as "Very High"

when 65% or greater are making progress toward English language proficiency. AVCS has 70.3% making progress toward English language proficiency. In the area of chronic absenteeism, AVCS has 2.3% chronically absent putting the school in the blue category (the highest level of excellence and the best rating for the Chula Vista Elementary School District). Reflection on the data for English learners that are Reclassified, demonstrates they are among the top learners in the school community.

#### **Reflections: Identified Need**

Although Arroyo Vista Charter School has had success with English Learners and other under-represented groups, we would like to continue to maintain that high performance while continuing to close the gap for low-income students. AVCS will work to insure access to a broad course of study for all students, reduce suspension rates (currently 0.5%), and insure that AVCS has an improving local climate. English learners that have not Reclassified face growing challenges as they risk becoming long term English learners (LTELs).

# **LCAP Highlights**

Arroyo Vista Charter School is focused on getting back to teaching and learning. There is a strong emphasis on providing each student with the educational climate and support they need to be successful. We continue to address the issues of learning loss and continue our tradition of academic excellence. Based on data collected and analyzed during 2018-2019, 2019-2020, 2020-2021, and the 2021-2022 school years, as well as the input from stakeholders, our LCAP focuses on the following: 1) Maintaining a robust Curriculum Experts program that teaches the whole child, including drama, music, art, and P.E. As a component of this curriculum experts program, classroom teachers are able to look at student data and plan interventions for students during C.E. time. 2) Providing a strong intervention program for struggling learners that implements Instructional Aides. 3) Training teachers in GLAD strategies for language development and taking the next steps to implement NGSS in all classrooms. 4) Closing the gap for learning loss that may have taken place over the last year and a half during the pandemic. This includes providing for mental health and behavior situation that can arise in both structured class times and less structured recess, lunch, and other times. That is why there continues to be a emphasis on behavior, social-emotional learning and supervision.

# **Engaging Educational Partners**

During the course of the 2021-2022 school year, several online and in-person meetings were held with educational partners. TEAM Council meetings were held on August 26, September 16, October 21, November 18, January 27, February 17, March 3, April 21, and May 26. ELAC meetings were held on the same days but in the morning. PTA meetings were held July 14, August 19, September 2, October 21, November 18, January 14, January 27, March 11, March 17, May 21, and May 28. During these meetings, there is a specific reporting time where educational partners are informed about the LCAP and the funding priorities that have been established the year prior. There is also solicitation for input. The design of our survey was brought to each of these groups. They were grateful to have input on the questions that were going to be asked for the survey. There was also an explanation of our achievement data highlighting our high need students and discussion about the Local Control Accountability Plan with each of these educational partner groups.

A summary of the feedback provided by specific educational partners.

Through conversations, interviews, and surveys, specific areas of priority included counseling, Instructional Aides, and Curriculum Experts. These have been strong areas in the past for us and they see to be areas of priority for us again. The area of counseling seems to be gaining ground as we have had a strong counseling program established.

We have not made any substantive changes to this plan.

An explanation of material differences between Budgeted Expenditures and Estimated Actual Expenditures and/or Planned Percentages of Improved Services and Estimated Actual Percentages of Improved Services.

Action items 1 and 2 did not demonstrate material differences between budgeted expenditures and estimated actuals (planned improved services). In item 3, there was significantly less (\$20,000) spent on the training as we used a county service for our teacher training that ended up being much less expensive. This year we plan on a more robust and individualized training model for our teachers. Action 4 was also a smaller amount that budgeted (\$15,000) as third party tutoring was only offered online which we wanted to move away from. The inperson tutoring (extended day program) that was implemented involved a smaller number of staff members that we had anticipated.

An explanation of how effective the specific actions were in making progress toward the goal.

Action 1 is on target for being met in both long-term and year-by-year progress. Action 2 was a challenge in 2020-2021 because of staff shortages/sub shortages. We expect to be closer to our target for that action item in the 2022-2023 school year. Action 3 requires more staff input and feedback to target the training areas of need (differentiated PD). Action 4 is building upon the success of the previous years and we are looking into other options to provide the tier 2 interventions to students.

The consideration of AVID and an independent study period in the middle school was borne out of the needs students present and the challenges in meeting those needs during the school day. Options outside the school day have not been as viable as we had originally envisioned. After-school tutoring (extended day) programs have become less frequent with our current teaching staff. We will need to look at ways to address this as well.

Mental health has taken center stage with recent developments and the pandemic status we have found ourselves in for the last two years. Many of our struggling learners face challenges that can be attributed to mental health. Emotional security and safety have long been a priority at AVCS. In a lower tier (yet still priority area) outreach to under-represented groups and families will help provide support to those students and families.

In the area of mental health, there was an incredible spike in incidents, referrals, and crisis interventions. This has become an extremely high needs area, particularly for students with special needs, foster youth, homeless and English language learners. Supervision staff have also intervened and prevented countless incidents on the playground and in the lunch area.

Again, the safety/health restrictions made recruiting very challenging this year. Going forward, we will need a return to recruiting at in-school parent events, parent conferences, in-person PTA events, etc.

(Measurable Outcomes [Effective In])

  - This percentage is the Total Estimated Actual Expenditures for Contributing Actions (7) divided by the LCFF Funding (9), then converting the quotient to a percentage and adding the Total Estimated Actual Percentage of Improved Services (8).
- 12. LCFF Carryover Dollar Amount LCFF Carryover (Subtract 11 from 10 and multiply by 9)
  - If the Estimated Actual Percentage of Increased or Improved Services (11) is less than the Estimated Actual Percentage to Increase or Improve Services (10), the LEA is required to carry over LCFF funds.

The amount of LCFF funds is calculated by subtracting the Estimated Actual Percentage to Increase or Improve Services (11) from the Estimated Actual Percentage of Increased or Improved Services (10) and then multiplying by the Estimated Actual LCFF Base Grant (9). This amount is the amount of LCFF funds that is required to be carried over to the coming year.

- 13. LCFF Carryover Percentage (12 divided by 9)
  - This percentage is the unmet portion of the Percentage to Increase or Improve Services that the LEA must carry over into the coming LCAP year. The percentage is calculated by dividing the LCFF Carryover (12) by the LCFF Funding (9).
