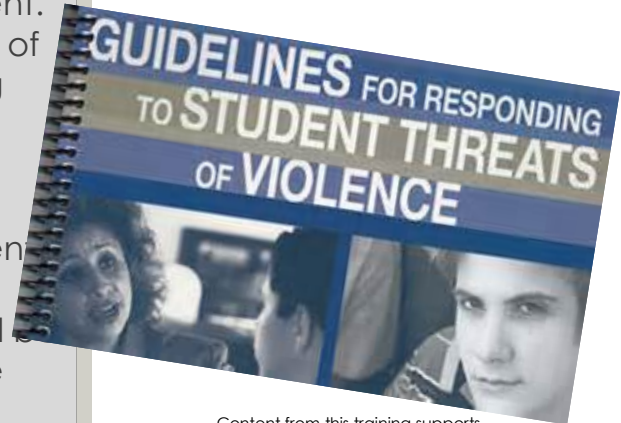

Targeted school violence is rarely an unpredictable event. Acts of this type are usually preceded by days or weeks of thought and planning. In most cases, students planning violent acts communicate their intentions to others.
